I respectfully submit a second complaint concerning Jordan Ray, a candidate for Justice of the Peace in the Highland Precinct who has violated a multitude of ethical rules outlined in the Arizona Code of Judicial Conduct (ACJC) and statutory rules established by the Arizona Supreme Court.

As mentioned previously, both Mr. Ray and I are candidates for the Highland Precinct Justice of the Peace. I filed a statement of interest on 9/10/2019 and Mr. Ray filed the same documentation on 9/30/2019. Additionally, Mr. Ray publicly announced that he was running for the vacant Highland position on or around 2/6/2019 and formally filed as a candidate for justice court on or around April 6, 2020, making him subject to the ethics guidelines in Canon 4.

This complaint focuses on three violations: 1. Mr. Ray's deliberate designation as campaign treasurer in his own campaign, 2. Mr. Ray continues to hold a leadership position and holds office in a political organization and will appear twice on the Primary Ballot, and 3. Mr. Ray is misleading voters about his legal qualifications and is engaging in the unauthorized practice of law.

1. Jordan Ray is the treasurer of his own campaign

Rule 4.1 (A)(6) of the ACJC restricts a judicial candidate from "personally soliciting or accepting campaign contributions other than through a campaign committee authorized by Rule 4.4." Comment 1 of Rule 4.4 states "Judicial candidates are prohibited from personally soliciting campaign contributions or personally accepting campaign contributions. See Rule 4.1(A)(6)." Comment 2 of Rule 4.4 states "Campaign committees may solicit and accept campaign contributions, manage the expenditure of campaign funds, and generally conduct campaigns. Candidates are responsible for compliance with the requirements of election law and other applicable law and for the activities of their campaign committees." Clearly, the ACJC requires that all judicial candidates allow their committee members to exclusively manage and solicit campaign funds, while the candidate has no involvement in the campaign donations or expenditures and oversees the committee's activities. Also of note, the ACJC does not differentiate between personal financial contributions, the contributions of others, or campaign expenses. Rather, the candidate must be separated from all campaign finances. This is further underscored by the guidelines in the Candidate Committee Handbook, 2020 (published by the Maricopa County Elections Department, page 9) which explains that "Justice of the Peace candidates cannot be their own Treasurer."

On May 22, 2020, (over a month after it was signed on April 17, 2020) Jordan Ray listed himself as the treasurer on his campaign committee statement of organization, submitted to the Maricopa County Department of Elections (See Attachment 1). This effectually established that he has been involved in the monetary dealings of his campaign from September 30, 2019 (Attachment 2) to the present date. Alarmingly, Mr. Ray was made aware that he was in violation of this rule by another judicial candidate on May 29, 2020 but chose to ignore the notification (Attachment 3).

2. Jordan Ray continues to hold a leadership position and holds office in a political organization

Rule 4.1 (A)(1) of the ACJC states that "A judge or a judicial candidate shall not do any of the following: (1) act as a leader in, or hold an office in, a political organization." Comment 3 of Rule 4.1 further elaborates that "Examples of such leadership roles include precinct committeemen and delegates or alternates to political conventions. Such positions would be inconsistent with an independent and impartial judiciary."

Jordan Ray continues to function as a precinct committeeman for the Republican Party in LD12, and will appear on the primary ballot to be simultaneously elected as justice of the peace and to be elected as a precinct committeeman. According to the June 5th, 2020 precinct committeeman report published by the Maricopa County Elections Department, Mr. Ray is listed as a precinct committeeman in the Towne Meadows voting precinct within LD12 (Attachment 4). Additionally, Mr. Ray has been attending LD12 meetings as a precinct committeemen either in person or through video conference since he filed his statement of interest on September 30, 2019, and has attended exclusive meetings meant only for elected leaders of LD12. Mr. Ray is also a member of a Facebook group specifically for precinct committeemen of LD12, and has unfettered contact to the inner workings of LD12 that other judicial candidates are not allowed to access.

Jordan Ray's duel ballot status on the Republican Primary Ballot was intentional. In order to appear as justice of the peace and as a precinct committeeman candidate Mr. Ray had to submit a nomination petition for each office, essentially gathering signatures for both offices simultaneously and submitting them to the recorder's office. Additionally, Mr. Ray would have received notification shorty after submitting the nomination forms to the elections office confirming the spelling of his name for the ballot of each office. Mr. Ray also did not withdraw his nomination from either office before the May 29th deadline established by the elections office, so his name will appear twice on the August 4th Primary Ballot.

Regardless of violating an ethical rule, Mr. Ray is creating voter conflict by presenting himself for election multiple times on the same ballot. Voters will now be required to knowingly vote for a candidate seeking election in two competing offices, or have to choose which office, if any, to elect Mr. Ray. Such voter decisions are unprecedented for a judicial candidate, and puts other candidates running for the same office at a disadvantage because Mr. Ray can pick and choose which office to hold if he wins the majority of votes in each race, while simultaneously siphoning off votes that would have gone to either judicial candidates or precinct committeemen. Additionally, Mr. Ray has made no attempt to inform voters of this issue or to clarify his position to the public at large as to why he submitted two separate petitions for two offices he cannot hold simultaneously, and why he will appear twice on the ballot.

3. Jordan Ray is misleading voters about his legal qualifications and is engaging in the unauthorized practice of law.

Rule 4.3 (A,F,H) of the ACJC does not allow a judicial candidate to "post, publish, broadcast, transmit, circulate, or distribute information concerning the judicial candidate or an opponent that would be deceiving or misleading to a reasonable person... Misrepresent the identity, qualifications, present position, or any other fact about the judicial candidate or an opponent... Make a false or misleading statement concerning the professional, occupational, or vocational licenses held by a judicial candidate, or the candidate's employment history and descriptions of work-related titles or positions. Additionally Arizona Revised Statutes Rules of the Supreme Court of Arizona Rule 31 2 (A)(4) considers an individual to be practicing law by "preparing any document through any medium for filing in any court, administrative agency or tribunal for a specific person or entity," while the State Bar of Arizona further elaborates on its webpage¹ that "only active members of the State Bar of Arizona and other persons who comply with the Arizona Supreme Court's rules regarding the practice of law may provide legal advice in Arizona."

On his webpage, Jordan Ray's campaign slogan is "Experience that Counts" (Attachment 5). Additionally, on the same campaign webpage Mr. Ray claims that he has: 1. Assisted in over 250 trials, mediations and arbitrations over the last 19 years, 2. Extensive background in the fundamentals of both criminal and civil litigation, 3. Traveled throughout the United States working in hundreds of courtrooms, 4. During his 19 years of litigation technology consulting, Jordan has consulted with attorneys on more than 250 trials, arbitrations, and mediations. Jordan has been part of many of the largest trials in US history, 5. As part of Jordan's career, he has traveled extensively nationally and internationally to support complex litigation, been a frequent guest speaker at legal conferences and CLE events, and published numerous articles regarding litigation technology (Attachment 6).

Upon further investigation to his claims that he has been involved in CLE events, Mr. Ray claims that his specialties and areas of practice include alternative dispute resolution, criminal law, employment law, intellectual property, law practice management, litigation, personal injury, and real property. In his biography on the same webpage Mr. Ray states that he has "personally assisted in over 75 trials, arbitrations, and mediations" (Attachment 7).

Additionally, on Mr. Ray's LinkedIn profile, he claims to be a member of the State Bar of Arizona and that he is a member of the bar's Technology Committee (Attachment 8). A simple member search of the Arizona State Bar's website reveals that Mr. Ray is not a member of the bar in Arizona. The Arizona State Bar has also confirmed the non-

existence of an actual technology committee, and that Mr. Ray is not a member of its Technology Working Group. Upon information and belief Mr. Ray has neither passed a bar examination, is not licensed to practice law in any United States jurisdiction, and is not a member of any group or committee of the Arizona State Bar.

Even if Mr. Ray were to somehow justify that each one of these statements in technically correct, it does not absolve him of the fact that he still violates the ACJC's reasonable person standard in Rule 4.3 (A). In fact, comment 1 of ACJC Rule 4.3 requires that "A judicial candidate must be scrupulously accurate, fair, and honest in all statements made by the candidate and his or her campaign committee. This rule obligates the candidate and the committee to refrain from making statements that are false or misleading or that omit facts necessary to avoid misleading voters."

On its face, Mr. Ray is promoting himself to have the same legal attributes of an attorney, providing legal guidance to other attorneys, and has related courtroom experience. By advancing this narrative, Mr. Ray is attempting to mislead a reasonable voter to conclude he has legal experience and qualifications he does not possess. Mr. Ray also makes a vague and unconfirmed claim that he has "been part of many of the largest trials in US history" without providing specific case names or explaining the contributions in such cases. Additionally, Mr. Ray has not made any attempt in any of his campaign literature or other published media to inform the voters that his in not an attorney, or has not acted in a legal capacity relating to the listed casework or courtroom appearances.

The matter of Mr. Ray's unauthorized practice of law has been referred to the Arizona State Bar for further investigation.


