REGULAR INFORMATION FORM

That on the $\underline{4}^{th}$ day of $\underline{August, 2020}$ at approximately $\underline{1300 \text{ hours}}$, the affiant learned the following information in the following manner:

SYNOPSIS

Your affiant was advised to contact the Yuma County Recorder's Office in reference to alleged ballot tampering during the primary elections. A time was set up for the following day to meet with employees and the county recorder so that your affiant could learn about what was being alleged.

Prior to the meeting your affiant was advised that deputies working the election detail obtained the sealed ballot box, box number 11, and escorted it to the Yuma County Recorder's Office where it was locked in the elections vault.

Your affiant was advised that a write in candidate, identified as Gary SNYDER, had recorded video on the day of the primary election in the parking lot of the Cultural Center in the City of San Luis, Arizona. Your affiant learned that he was beyond the 75 foot limit required for him to take videos near the polling center.

Your affiant was told that Mr. SNYDER was taking videos of a group that had set up a table outside of the 75 foot limit and was encouraging people to vote. The group mostly consisted of people wearing blue shirts with the words "Juntos Saldremos Adelante" which roughly translates to "together we will move forward".

Your affiant obtained a copy of the video and, after further investigation, was able to identify the subjects in the group. During the course of the video a woman, identified as Alma JUAREZ, approaches the group and speaks to a woman wearing an open top hat, white in color, and a blue shirt, identified as Guillermina A. FUENTES. Alma JUAREZ hands Guillermina FUENTES a ballot envelope with the flap of the envelope unsecured. Guillermina opens the envelope, obtains what appears to be a pen and makes a motion on the ballot that appears to be her filling in the boxes on the ballot. Guillermina FUENTES appears to be filling in 3 boxes as she does this. It appears that she does this three additional times as well however it is unknown if it is the same ballot or a separate ballot. Gullermina then closes the ballot, obtains a bottle of water, wets her finger and seals the envelope with her wet finger. Guillermina then opens a folder that is on the table and retrieves 3-4 additional ballot envelopes and hands them to Alma JUAREZ. Alma JUAREZ then walks into the voting center at the Cultural Center where, your affiant was told, Alma JUAREZ drops the ballots into the ballot box and proceeds to a booth to vote.

Your affiant contacted Alma JUAREZ and she stated that her sister had given her the early ballot to drop off for her as Alma had not received an early ballot and told her that she had to go in a vote. She advised that her sister had given her the ballot envelope, open, so that election officials could check it to make sure that she had completed it correctly. Alma JUAREZ initially stated that Guillermina FUENTES had not written on the ballot but would later state that she did but she did not know what she wrote on it. The sister of Alma JUAREZ was identified as Hilda Griselda JUAREZ.

The sister of Alma, identified as Hilda Griselda JUAREZ, advised that she completed her ballot and sealed the envelope. Hilda JUAREZ stated that she gave her sister, Alma JUAREZ, a sealed ballot envelope to turn in when she went in to vote that day.

Your affiant was present at the Yuma County Recorder's Office on the day that box number 11 was opened. Your affiant made sure that election officials took care in handling the ballots and wore gloves. The ballots envelopes were not opened at that time and just the signatures were "verified". Your affiant observed this process and saw the ballot envelope for "Hilda JUAREZ among the approximately 40 ballot envelopes that were inside of box number 11.

The ballot envelopes were then copied by election officials, while wearing gloves and the originals were turned over to your affiant and submitted to Sheriff's Evidence under item numbers 1-38. Ballot numbers 39 and 40 were retained by the Yuma County Recorder's Office because they did not pass the signature test and the owners of the ballots needed to be contacted to confirm they had submitted one. The ballot belonging to Hilda Griselda JUAREZ was not one of the ballots retained by the election officials.

Item numbers 1-38 were then taken to forensic technicians at the Yuma Police Department for latent print examination. Item number 34, the ballot belonging to Hilda Griselda JUAREZ, along with item number 37, a ballot belonging to Guadalupe Tirado AMAYA, were looked at first at the request of your affiant due to one being the sister of Alma JUAREZ and the other appeared to have been taped shut rather the closed using the glue strip of the ballot envelope.

Your affiant was later advised that prints were located on the ballots that had previously been sealed inside of the envelopes, and case prints would be needed for a comparison. Your affiant was also provided with photographs of both ballots and found that only 3 votes are on each ballot, those of the 3 that are running in the local elections. No one else was voted for on the two ballots. The 3 subjects running in the local elections are Matias ROSALES, Gloria TORRES and Luis CABRERA and are the same subject that are being supported by the group "Juntos Saldremos Adelante".

With this warrant your affiant hopes to be able to obtain case prints from Guillermina A. FUENTES so that comparisons can be made to the latent prints lifted from the ballot belonging to Hilda Griselda JUAREZ. The same ballot that Hilda JUAREZ stated that she completed and sealed prior to handing it to her sister, Alma JUAREZ, to be dropped in the ballot box.

Therefore, Your Affiant believes that the following information demonstrates good cause, pursuant to A.R.S. Section 13-3917, for permitting this warrant to be served at any time of the day
